It should be reinstated as a wildlife area re the 1995 agreement. The planet needs more areas like this to survive.

The 1995 agreement was a wonderful way of providing a ecological buffer between the village and developments. I had visited the pools since they were created and were a fantastic area for wildlife. Even though there was no public access it acted as an oasis for many rare and scarce species of bird, amphibian insects and plants including 5 species of Orchid. A detailed ecological survey was carried out by the landowner (I know the individual ecologist employed) which was not in the public domain. I cynically believe this is the reason for the "tree management" being carried out in October 2019. This resulted in s pathetic attempt of relocating amphibians and reptiles to a wholly inappropriate replacement site. The vegetation has been completly decimated including a mature Oak that had a Tree protection order in place. The land is now being buried under thousands of tonnes of recycled building waste, hopefully free of Asbestos contamination. Has anyone certified/verified this.

There is an obvious increased flood risk to the village if the surrounding flood plain is being raised height as is the current case.

All of this seems to be occurring without a planning application or consultation.

We should try to keep it as a wildlife haven,in which the villagers can enjoy

This land has been made into an eyesore! Along this strip there are several parcels of land that have been destroyed ready for building but stand unwanted.

The replacement pools are also a joke, this would be a wild habitat for protected species such as crested newts and the replacement habitat is shameful! The owner of the land should be made to sort this as a matter of priority before anymore work happens on site.

This area has been destroyed !!! There is enough empty buildings in the area without destroying so much wildlife habitat !!!

They are breaking the law.

It is important that we preserve areas for wildlife for the good, not just of the local environment, but of the planet. Too many trees and spaces for nature are being destroyed, in this case it would appear even without planning permission. It needs to be stopped.

The destruction of the habitat at this site should have never been allowed to happen. This destroyed a lovely site full of wildlife in a time when any small piece of wild areas like this a precious and should be protected by development.

This company has taken no notice of the parishioners from day one, I think we are fighting a losing battle with no help from SG council, very sad.

It's devastating that a grade A wildlife sanctuary with the rarest birds and insects can be raped and pillaged before our eyes.

if there is any way of stopping it we need to try but expect as the efforts made early on was to no avail it may be too much time and money wasted I feel as a community we have been let down with lack of power from the parish Not worth the funding they get

As long as new, and significantly sized and accessible pools are created elsewhere locally, no problems with development.

We have enough warehouses around here, we are continually losing all our green spaces

Very disappointed with South Glos Council not protecting the natural habitat for many species of bird, bats and owls etc. let alone the homeowners in close proximity that are having to witness and endure the desecration

This was an area of beauty as well as wildlife and should never have been removed to build warehouses

The destruction of a natural habitat for countless creatures is disgusting. I could understand it if it was justified, but this is unnecessary development. I'm very unhappy with the 'replacement ponds' that are effectively 10% of the original size.

With all the non developed land available further in the distribution park and towards Avonmouth, it is totally uncalled for and unwarranted, to have flattened what was a beautiful and natural barrier between Severn Beach and the distribution warehouses on the Western Approaches. Also removing the trees has caused the noise levels to increase, disturbed the wildlife and its habitat that has developed there over the last 30 - 40 years, and the housing in the general area has no doubt, been devalued.

Developers have a total disregard to the affect this has had on the residents of this area.

We need more feedback as to what SGC have authorised to progress on this site. Many rules seem to have been broken the TPO for the Oak tree to name one.

We as a community are not kept informed as to what is legal and what is not.

What steps have SGC made to correct any misdemeanours?

SGC's core statement says that they are open and transparent!

The last few weeks we have had to put up with the lorries passing Orchard Pools site sounding their klaxon horns for reasons only known to themselves. It is annoying and antisocial. It has been reported but I will probably have to endure another 10 days or so of Klaxons before I get a reply from SGC.

The area is very visible (Severnwood Gardens) from my lounge window and an increase in noise from further developments has already been noticed since the natural buffer of trees and hedgerow has been removed. I dread to think of the further increase of noise and activity should the area be built on.

We are being swallowed up by development

I am worried about flooding because of all the building on flood plains. I am also concerned about the removal of important trees and the decimation of wildlife habitats

Why have they been allowed to get any with this much destruction already?

Our street is opposite and we already have the Western Approaches at the back of us. Enough is enough. Would the developers want it on their doorstep? I think not.

We are devastated by what's happening we live in Severnwood gardens the first road behind it and the destruction of the woodland and wildlife was absolutely horrendous. We are a family of 4, 2 small children and every weekend we used to walk there now we can't. And the noise in our back garden and dust it's creating is shocking. I'm a childminder and I've had to think carefully about when to have the children outside. We don't need more warehouses there. We do need protection against the noise of the currant ones that are there. This should not be allowed to go ahead.

This was done behind our backs

We moved in in September 2019 and it was glorious seeing a really old wood, ponds and fields. Then they were demoliting the wood saying it was wood/forest management (my arse). Wood management is felling 1 or 2 out of 10 trees to let them grow bigger. It's also putting up mounds off wood so creatures can use them as homes etc. It does not mean felling every single tree and digging up absolutely everything. The single oak that was left (immaculately) under a preservation order was then demolished cos it was damaged!!! This is an absolute lie, there was nothing wrong with it, it was just in their way.

The new ponds are totally inadequate and not lined so any water in them just seeps away killing any wildlife. Apparently some of the newts etc were transported over in buckets and there is now approx 1ft of water. Not sure if the newts or any wildlife are still alive. I have photos of all three ponds.

These woods were protected under a 1957(?) protection order and this should have been adhered to. Also the woods and the pools are drainage for the surrounding area.

Where is the water going now?

Question - Why are the increasing the land level? This could mean the rain water will come into the village. Are we going to get compensation of sorts if that happens?

South Glous council seem toothless

Apparently there is no planning approval for any development yet, so why they are causing a lot of disruption, noise and dust pollution for no actual reason yet is beyond me.

If a `Buffer Zone` was deemed necessary a few years back then surely it's still required? and of course any development of this scale will increase flood risk

Living in abbott road at the top of the beach we have had no information at all and the noise if awful

Terrible destruction to the wildlife and look of the area. Plenty of land near avonmouth that can be used. No planning permission to build on it and the owner doesnt even live in Bristol!

I have been reliably informed that the contractors lied about the number of great crested newts in the ponds. We were all aware it was a good colony, protected by law. I cannot believe the South Gloucestershire Council are not legally, or morally bound, to replace the number of trees it fells. In the works near Henbury ford, Bristol City council have to restore 1.5 trees for every tree it has removed. The number of trees and the area of habitat we have lost in the last four years is deeply depressing. I don't like living here anymore because of this destruction.

This destruction of habitat is wrong and should be stopped. An oak tree hundreds of years old was removed, the ponds with their abundance of Great Crested Newts ruined and hundreds of birds and animals left homeless.

The South Glos. council have a moral duty to stop this. Have the Avon Wildlife Trust been contacted?

My concerns are environmental. Where will the excess rainwater go? Where have the birds and other wildlife gone? I think South Gloucestershire Council have let us down and continue to let us down. The number of trees and the area of habitat lost in the last few years is shocking. It must stop!

We are losing our community to industry.

We are at a point that regardless of which direction we travel in that we are encroached by developments losing so much of our wildlife and the environments in which they flourish.

The noise and constant buzzing is impacting residents time at home.

Unless planning permission is granted then development should not continue. My family and I were saddened to see all of the trees cut down and I am angered that this was done without planning permission.

Our green areas are getting smaller and smaller orchard pools was a great facility for residents, dog walking running bird watching and lots of wild life to observe. It's criminal what has happened give it back to the residents!

This is the thin end of a wedge which needs to be stopped. All brown field sites should be developed as a priority.
